1) ALL SALES ARE FINAL:

Customer hereby agrees to Adventure Cell Corps Terms & Conditions. These stipulations are inclusive, but not limited to the following: As a standard practice, to the extent allowed by equipment manufacturer, Adventure Cell Corp will assist customers in warranty claims. Adventure Cell Corp. charges actual shipping fees. Refused or undeliverable shipments will be subject to a restocking fee of 20% in addition to applicable shipping, transaction and insurance fees. Equipment prices are subject to change. All activation charges and prepaid airtime are NON-REFUNDABLE.

2) AVAILABILITY OF LIMITED SERVICES:

Service is generally available to satellite terminals equipped for this service when within the satellite footprint. Service is furnished to Customer or Customer's authorized user. A telephone number may not appear in more than one terminal. Customer has no property rights in such number. Adventure Cell reserves the right to assign, designate, or change such number, when, in its sole discretion, such action is reasonably necessary in the conduct of its business.

3) ADVENTURE CELL SERVICE:

Customer has contracted to have Adventure Cell provide the service. Iridium service is provided through stations operated by and roaming agreements of Iridium Satellite USA.

Early Terminations:

Early terminations within the first year are subject to a \$250 cancellation fee. Customer may renew for successive one (1) year service periods at the same terms and conditions contained herein. Notice of termination should be made in writing to Adventure Cell at 2221 Peachtree Rd. NE, Suite D371, Atlanta, GA 30309 USA no less than thirty (30) days prior to the expiration of any term of this Agreement Adventure Cell reserves the right to terminate this Contract at any time during the contract period.

4) LIMITATION OF LIABILITY:

The satellite services provided by Adventure Cell may be temporarily interrupted, delayed, or otherwise limited and is not available everywhere in the world. Adventure Cell makes no representation that it can provide uninterrupted service. Furthermore, Adventure Cell shall not be liable for acts or omissions of other carriers, equipment failures, or modifications, acts of God, strikes, government actions, or other causes beyond our reasonable control.

5) LICENSING:

This contract is governed by the laws of the state of Georgia and applicable tariffs.
CUSTOMER AGREES THAT ANY LEGAL PROCEEDING COMMENCED BY ONE PARTY AGAINST THE OTHER, SHALL BE BROUGHT IN ANY STATE OR FEDERAL COURT HAVING PROPER JURISDICTION WITHIN THE STATE OF GEORGIA. BOTH PARTIES SUBMIT TO SUCH JURISDICTION AND WAIVE ANY OBJECTION TO VENUE AND/OR CLAIM OF INCONVENIENT FORUM.
